## NOTICE OF SCHEME MEETING

**NOTICE IS HEREBY GIVEN** that by an Order of Court dated 28 June 2022 (the "Order") the Court has directed that **HIAP SENG ENGINEERING LIMITED (UNDER JUDICIAL MANAGEMENT)** (UEN No. 197100300Z) (the "**Company**") do convene a meeting (the "**Scheme Meeting**") of the Scheme Creditors (as defined in the Scheme) via Video-Conference (unless otherwise notified by the Company), <u>on 18 August 2022 at 2:00PM (Singapore time)</u> for the purpose of considering and, if thought fit, approving (with or without modifications) the Scheme of Arrangement (the "**Scheme**") proposed by the Company (under judicial management) to be made between the Company and its creditors, and any other incidental matters, at which place and time the Scheme Creditors are requested to attend.

The Scheme Creditors may vote in person at the said Scheme Meeting or they may appoint another person, whether a Scheme Creditor of the Company or not, as their proxy to attend and vote in their stead.

Every creditor of the Company shall submit a Proof of Debt (if you have not submitted one earlier) to the Company c/o Mr Lin Yueh Hung and Ms Oon Su Sun, both care of RSM of 8 Wilkie Road #03-08 Wilkie Edge Singapore 228095 or by email to <u>RF-HiapSengEngineering@RSMSingapore.sg</u> by no later than **2:00PM on 12 July 2022** (the "**Proof of Debt Submission Date**"), for the purposes of voting at the Scheme Meeting and participating in the Scheme.

The Proofs of Debt shall be reviewed by the Company and adjudicated by the Company, in consultation with the Scheme Managers, for the purposes of voting at the Scheme Meeting. Such Proofs of Debt shall be denominated in Singapore Dollars (S\$) at the Exchange Rate (as defined in the Scheme) as at the Ascertainment Date (as defined in the Scheme).

Any creditor who fails to lodge his Proof of Debt by the Proof of Debt Submission Date shall not have his claim admitted by the Scheme Managers for the purposes of the Scheme and shall not be entitled to receive any benefits under the Scheme.

If a majority in number representing three-fourths in value of the Scheme Creditors present and voting either in person or by proxy at the Scheme Meeting (or any adjourned Scheme Meeting) agrees to the said Scheme, with or without modification, such Scheme shall be binding on all Scheme Creditors of the Company if approved by a subsequent Order of Court.
